

Privacy Statement Conference Calls for Analysts, Investors and Press

The following notes contain information on how your personal information is processed by Klöckner & Co SE, and on your rights pursuant to the data protection laws.

Who is responsible for the data processing?

Klöckner & Co SE, Am Silberpalais 1, 47057 Duisburg, Germany

For what purpose is your data processed, and on what legal basis does this take place? From where does Klöckner & Co SE obtain your data?

Klöckner & Co SE processes your data for the purpose of protecting legitimate interests in accordance with Section 6 para. 1 f) GDPR to collect statistical information on the number of participants. The aim here is primarily to separate internal from external participants and thus obtain more accurate figures. Furthermore, you have the possibility to raise questions. If you wish to do so, we need your data to call you by name.

Our legitimate interests lie in the pursuit of the aforementioned purposes.

Your data will not be used for marketing purposes.

To what categories of recipients might your data by relayed?

External service providers: Klöckner & Co SE uses the services of external providers for hosting the telephone conference and the webcast as well as it-infrastructure provider for internal collaboration.

For how long will your data remain stored?

The retention period for data recorded usually amounts up to 30 days. As a general rule, your personal data shall be deleted or anonymized once it is no longer needed for the aforementioned purposes.

What are your rights?

Your rights as a data subject under the General Data Protection Regulation (GDPR) – subject to the applicable legal requirements being met – are as follows:

Access: You have the right of access to personal data concerning you that we process.

Rectification: You have the right to obtain rectification of your personal data. You also have the right to have incomplete personal data completed.

Erasure: In certain instances, you have the right to obtain erasure of your personal data.

Restriction of processing: In certain instances, you have the right to have us restrict the processing of your personal data.

Data portability: If you have provided us with data on the basis of a contract or consent, you have the right to receive the data you have provided in a structured, commonly used and machine-readable format or to have us transmit it to another controller.

Revocation of consent: If you have given us consent to the processing of your data, you can revoke it at any time with effect for the future. This does not affect the lawfulness of the processing of your data prior to the revocation.

Right to object: Where we process your personal data on the basis of our legitimate interests pursuant to Article 6(1)(f) of the GDPR, you have the right at any time to object to processing of your personal data, on grounds relating to your particular situation; this includes profiling based on those provisions. We will then no longer process the personal data for the stated purposes unless we can demonstrate compelling legitimate grounds for processing that override your interests, rights and freedoms, or the processing is for the purpose of establishing, exercising or defending legal claims.

Right to object to processing of data for direct marketing purposes: You have the right to object at any time to the processing of your personal data for direct marketing purposes. If you object to processing, your personal data will no longer be processed for those purposes. This includes profiling to the extent that it is related to such direct marketing.

Exercising your rights:

To exercise any or all of your rights as described above, please contact your customer service representative or contact us using the contact details provided under heading I above. Alternatively, you can also contact the Data Protection Officer (see heading II for contact details). Please make sure that we can clearly identify you.

Right to lodge a complaint with a supervisory authority:

You have the right to lodge a complaint with a supervisory authority – in particular, in the Member State of your habitual residence, place of work or place of the alleged infringement – if you consider that the processing of personal data concerning you is unlawful.
